**Note to residents of Magnolia Chase Subdivision.** Please consider paying homeowner association dues for 2017. The BANA Treasury covered the entire cost of the new Magnolia Chase Subdivision sign that was installed in 2014. Dues collected from Magnolia Chase residents since 2012 total \$1,050.00 or 56.5 % of the cost of the sign (\$1,858.00). Only one of the 30 Magnolia Chase residents paid dues in 2016 and a total of four this year (2017). Let's reimburse the BANA coffers! ### SEWER PROJECT

You noticed that there was a lot of construction happening in our subdivision. The city upgraded our sewer pumps and sewer lines. The project is now finished. The city recommends several ways to reduce your sewer bill:

- Reduce water usage during averaging months (Oct.-Dec; Feb.-April)
- Limit lawn watering
- Repair leaking toilets and faucets
- Report water meter leaks to the water company

Your membership dollars are at work! BANA decided in its last meeting to use part of the membership funds for the upkeep and maintenance of the areas around our signs and the overgrown area at the exit of King James to Siegen Lane. Plans for updating the Barkley Place sign and creating a sign for Siegen Village are underway. Stay tuned!
