Traffic Calming Measures- Last October, speed control signs were placed on Barkley



and King James streets. This was a second study that the city of Baton Rouge -Traffic Engineering

Office conducted to quantify the volume and speeding traffic through our neighborhood. The study revealed that volume of traffic does not qualify for the installation of speed bumps on the streets at this time. However, please continue to report speeding, parking, or stop sign violations in our neighborhood to the East Baton Rouge Parish Sheriff's Office - Traffic Enforcement at (225) 389-4851.
